COVID-19 SAFETY INFORMATION

- 3. Individuals who believe that they may have been exposed to a confirmed or suspected case of COVID-19 or have been diagnosed with COVID-19 and are not yet cleared as non-contagious by state or local public health authorities or the health care team responsible for their treatment.

DUTY TO SELF-MONITOR:

Attendees agree to self-monitor for signs and symptoms of COVID-19 (symptoms typically include fever, cough, and shortness of breath) and, contact God is Love, Inc at godislovenfp@gmail.com if she experiences symptoms of COVID-19 within 14 days after attending the retreat.

RELEASE AND WAIVER.

I understand that the risk of becoming exposed to and/or infected by the Coronavirus, COVID-19, or other disease may result from the actions, omissions, or negligence of myself and others.

I voluntarily choose to attend the SAS Retreat provided by God is Love, Inc and acknowledge that I am increasing my risk to exposure to the Coronavirus/COVID-19.

I HAVE CAREFULLY READ AND FULLY UNDERSTAND ALL PROVISIONS OF THIS RELEASE, AND FREELY AND KNOWINGLY ASSUME THE RISK AND WAIVE MY RIGHTS CONCERNING LIABILITY AS DESCRIBED ABOVE.
